NOTIFICATION OF CHANGE OF BY-LAWS STRATA TITLES ACT 1985 SECTION 42

The Owners of Osborne Gardens Strata Plan 28 hereby certifies that by Special Resolution duly passed at a meeting of the Strata Company on 21 August 2013 and which became unconditional on 21 September 2013 the bylaws in Schedule 2 to the Act as they applied to the Strata Company were repealed and added to as follows:

Schedule 2 By-law 12(c) is repealed and the following new Schedule 2 By-law 15 is added:

New by-law 15

- 15. Animals
- 15.1 Subject to section 42(15), a proprietor, occupier and their invitees shall not bring or keep any animal on the parcel without the written consent of the strata company.
- 15.2 The strata company will not withhold its consent if the animal is of a breed or size that is in its reasonable opinion, in all the circumstances, suitable to be kept as a domestic pet in the scheme.
- 15.3 A person to whom consent has been given shall:
 - 15.3.1 be responsible for the health, hygiene, control and supervision of any animal in their care;
 - 15.3.2 prevent any animal in their care from regularly making a noise or behaving in a manner that disturbs another proprietor, occupier or their resident or their invitees; and
 - 15.3.3 will take every action reasonably necessary to remedy a breach of sub by-law 15.3.1 or 15.3.2 within 14 days after receiving written notice to do so from the strata company.
- 15.4 A person to whom consent has been given shall not keep any animal on the parcel if:
 - 15.4.1 the keeping of the animal breaches any requirement of the local government;
 - 15.4.2 they have failed to comply with a notice given by the strata company pursuant to sub-bylaw 15.3.3, or
 - 15.4.3 they have received three notices issued under sub-bylaw 15.3.3 within a 12 month period.




15.5 A person to whom consent has been given shall indemnify and keep indemnified the strata company against all actions, claims, demands, damages, costs, suits or causes of action and losses of any nature whatsoever which the strata company may suffer or incur in respect of damage to property, death or bodily injury arising from or related to the animal the subject of any consent and that is occasioned wholly or in part by any wilful or negligent act or omission, breach of this by-law or breach of duty of care by the person to whom consent has been given.
