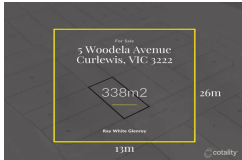


5 CHAPPELL AVENUE CLIFTON SPRINGS VIC 3222

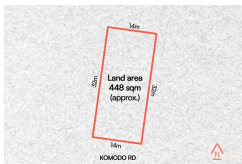
